- 1. Subject to the conditions and provisions of the advertisement, the above candidates during this period will be paid Rs.57,700-1,82,400 in the seventh pay commission for the post of Assistant Professor as per Academic Pay Level-10 and Rs.57,700/- and other allowances thereon as per the prevailing Govt. will be available as per rules. and till the completion of the probationary period he shall draw the same salary and shall not be entitled to any Increment. Increment will be admissible at normal rate only after appointment in place of Assistant Professors on regular basis after completion of trial period.
- 2. Whether probationary assistant professors are selected for training to make them more efficient when sent for training on deputation, obtaining their consent and extending their probationary period of training will be extended after informing them and obtaining their consent.
- 3. When orders for termination of probation are made, the period of probation shall be extended by the time of leave, training or period of training on deputation as per sub-para (2) applicable by the probation officer during the period of probation and the time of joining duty.
