A sanction has been given to 1053 filled academic temporary posts out of a total of 1329.5 total posts 985.5 at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue from 01/03/2023 to 29/02/2024 through resolution No. (1) mentioned above total 186 vacant teaching temporary posts were granted continuation from 01/03/2021 to 28/02/2022 vide resolution reference no. 2. And under New Matter 2021-22 out of total 105 posts of non-tribal colleges (out of which 100 posts of Assistant Professors and 05 posts of PTI), and out of total 53 posts of tribal area government colleges (50 posts of Assistant Professor and 03 posts of PTI) thus a total of 158 posts vide reference No. (3) Resolution are granted administrative sanction.

- 2. In the current Academic Year 2022-23, the posts filled by the Director of Higher Education as per Annexure-A are 1006.5, as per Annexure B vacant temporary posts for a period of less than 01 year are 178, as per Annexure-C, vacant posts held in abeyance for a period of 01 to 03 years are 112.5, and as per Annexure D vacant posts for over 03 years are 32.5, thus, a proposal to grant sanction to total 1329.5 teaching temporary posts from 01/03/2022 to 28/02/2023 for a further period was made vide above mentioned letter Reference no. (4) which was under consideration of the government.
- 2. After due consideration as per Annexure 1 attached herewith filled temporary 1006.5 posts, as per Annexure B the vacant temporary posts for a period of less than 01 year total 178 and as per Annexure-C the posts held in abeyance for a period of more than 01 year and less than 03 years total 112.5, thus a total of 1297 teaching temporary posts are granted permission to continue from 01/03/2022 to 28/02/2022 under the following conditions. Remaining total 32.5 temporary posts as per Annexure-D, having remained vacant for over 03 years, these temporary posts as per permanent instructions of



Finance Department are to be cancelled. The Commissionerate of higher Education must act accordingly.

Conditions: -

- 6. The temporary posts shall be used for the purpose for which they are sanctioned.
- If there is a need to continue the post, a proposal in this regard is to be made two months before the expiry of the temporary post with proper justification.
- 8. Vacant post for a period of more than a year should be placed in abeyance and the post vacant for a period more than 03 years should be cancelled.
- Vacancies placed in ABEYANCE cannot be filled without prior approval of Finance Department.
