Norms:-

- 1) The above candidates are entitled for the pay scale of 57,700-1,82,400/- as per the academic pay level 10 (57,700/-) for the post of Assistant Professor subject to the norms and provisions of the sald notification, and are entitled for other allowances as per the prevailing government norms. They are not entitled for any increment till the completion of their probation, and will receive the above-specified salary. On the completion of their probation, after their regular appointment as assistant professor, they will be entitled to get increments at the usual rates.
- 2) Whenever assistant professors are sent for training through selection or appointment To enhance the capability, their consent has to be received and they have to be intimated that their probation will be extended at par with the duration of the training. It is only then that they shall be sent for any kind of training.
- 3) The probation period of the concerned probationary officer shall be extended at par with the leaves availed during probation for training programs or any kind of counter appointment in accordance with para (2) mentioned above, when orders are issued regarding the completion of probation.
- 4) If any other leave other than commuted leave is availed during probation, the duration of the probation will be extended at par with the duration of leave.
- 5) The concerned appointee will have to carry out any other duty handed over by the government apart from the academic duty and they will be entitled for transfer at any place in the state.
- 6) If their service is not found satisfactory during the probation, their services can be ceased during the probation or on completion of the probation.
- 7) Language examinations as directed by the government (Hindi or Gujarati departmental exams or any other such exam) will have to be cleared during probation. If the candidate is unable to it in accordance with the departmental examination rules, his increments shall be ceased until he clears the specified exam.
- 8) The seniority of the candidates joining the service in the specified time limit shall be as per the sequence specified by the Gujarat Public Service Commission.
- 9) Matters of salary, leave, pension, conduct, etc. shall be subject to norms specified in Gujarat Civil Services Rules, Gujarat Civil Service (Conduct) Rules, Gujarat Civil Service Rules (Discipline and Appeal), etc. issued by the government from time to time.
- 10) The Principal of the concerned college shall verify whether the candidate joining has the educational qualification, experience, age, citizenship, gender etc. satisfying the recruitment norms as specified by Gujarat Public Service Commission.
- 11) The candidates eligible for the concerned post are recruited on an immediate and interim basis without medical verification, character certificate and police verification as per GAD
