Colleges under Education Department to continue till 29/02/2019 vide Resolution No. (1). In the current Academic Year 2019 the office of the Commissioner of Higher Education as per Annexure A proposal was made to continue 911.1/2 posts filled as Annexure A +226 as per Annexure B, thus a total of 1137.1/2 temporary posts from 1/3/2019 to 29/02/2020 was made by the office of the Commissioner of Higher Education as per Annexure (2), which was under the consideration of the government.

- If there is a need to continue temporary post, proposal for the same should be made 2
 months prior to its expiry date with proper documents.
- 5. Post vacant for more than 01 year should be placed in abeyance. And posts vacant for more than 03 years should be cancelled.

Resolution -

A sanction was given to 603.5 filled academic temporary posts and 527.5 vacant posts, thus a total of 1130.5 at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue till 29/02/2019 vide Resolution No. (1). In the current Academic Year 2019, the 122 posts as per Annexure B, 51 posts as per Annexure -C, 53 posts vacant as per Annexure D, thus a total of 226 vacant temporary posts. Proposal to continue these posts for a further period from 01/03/2019 to 29/02/2020 was made by the office of the Commissioner of Higher Education as per Annexure (3), which was under the consideration of the government.

2. After due consideration as per Annexure-B 122 posts (the posts vacant for less than 01 year) and as per Annexure-C 51 posts (the posts vacant from 01 to 03 years), thus total 173 vacant temporary posts are allowed to continue for a further period from 01/03/2019 to 29/02/2020, subject to the following conditions. - 4. If there is a need to continue vacant post, proposal for the same should be made 2 months prior to its expiry date with proper documents.
- 5. Post vacant for more than 01 year should be placed in abeyance. And posts vacant for more than 03 years should be cancelled and cannot be filled without prior approval of Finance Department.
