1. This appointment of this Contractual Assistant Lecturer is recommended by the Gujarat Public Service Commission for the selection of candidates for Gujarat Education Service Class-II on a regular basis to the Government and the appointment of regular lecturers in Government Colleges by the Education Department or the completion of the academic year 2015-16, whichever is earlier. - 3. If the performance of the candidate during the period of employment is not satisfactory or if there is any change in the workload of the concerned college based on the number of students, they will be dismissed from the job at any time in respect of the given appointment.
- 4. The candidate shall faithfully perform any duties assigned to them by the Principal of the institution for student development and any other duties. Additionally, the concerned contractual lecturer has to discharge all academic responsibilities assigned by the State Government or the University.

- 7. A candidate appointed as a contractual Assistant Lecturer shall not be entitled to any financial benefits other than those mentioned in this order.
- 8. If the candidate wants to resign from the job during the ongoing employment, the candidate has to give notice before 7 days or resign by paying 7 days' notice.
