Resolution –

A sanction was given to 911.5 filled academic temporary posts at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue till 29/02/2020 vide Resolution No. (1). In the current Academic Year 2020-21 the temporary filled posts as per Annexure A, 200.5 vacant posts for less than a period of 01 year, as per annexure -B, 44 posts vacant from 01 to 03 years (posts in abeyance), and as per annexure D, 49 posts vacant for over 3 years, thus a total of 1200.5 filled/vacant temporary teaching posts. Proposal to continue these posts for a further period from 01/03/2020 to 28/02/2021 was made by the office of the Director of Higher Education as per Annexure (2), which was under consideration of the government.

2. After due consideration as per Annexure-A attached herewith filled temporary 907 teaching posts are allowed to continue for further period from 01/03/2020 to 28/02/2021 subject to the following conditions.

Conditions: -

1. The expenses incurred on these posts for this purpose will be borne under provision made under budget estimate of 2020-21.
2. Expenses should be made within the limits of the grant disbursed by Finance Department.
3. Vacant post must be used for the purpose it is sanctioned.
4. If there is a need to continue vacant post, proposal for the same should be made 2 months prior to its expiry date with proper documents.
5. Post vacant for more than 01 year should be placed in abeyance. And posts vacant for more than 03 years should be cancelled.

This resolution is issued as per the sanction accorded by the Finance Adviser (Education) in the equal number file dated 10/06/2020.


