Conditions



- 1) Mr. Kurkutia Prafullbhai Babubhai, as an Assistant Professor during this time subject to the terms and conditions of the advertisement, he will be entitled to minimum pay as in the pay scale of the post of Professor will be Rs. 15600/- and other allowances will be admissible thereon. And during the entire period of probationary period he will get the above mentioned salary and he will not be entitled to any other increment until, to attain a normal rate only after appointment in place of assistant professor on regular basis post the probationary period.
- 2) To make the Probationary Officer more efficient when they are selected or deputed for training to inform them and obtain their consent that the period of probation will be extended by training.
- 3) When order for termination of probationary period is made, the probationary officers shall extend the probationary period by the amount of leave, training or training period on deputation as per sub-para (2) taken at the rate of probationary period and the time of joining duty.
- 4) If any leave other than casual leave is taken during the trial period, the period of trial shall be extended by the period of leave.
- 5) He will have to perform many educational and other duties assigned by the government and they will be eligible for transfer to any place in the state.
- 6) If his performance during the trial period is not satisfactory, his trial service will be terminated during the trial period or on completion of the trial period.
- 7) Shall pass the linguistic examination in Hindi or Gujarati language and such other examination as may be prescribed by the Government and applicable to them. If the linguistic test is not passed within the time limit prescribed in the Departmental Examination Rules, the subsequent 1st attempt will be withheld until they pass such test.
- 8) The seniority of the candidates appearing on duty within the prescribed time limit will be as per the order given by the Commission.
- 9) Salary, leave, pension, conduct etc. services subject and disciplinary subject to other matters of service conditions Gujarat Civil Service Rules, Gujarat Civil Service (Conduct) Rules and Gujarat Civil Service (Discipline and Appeal) Rules etc. shall be subject to the rules promulgated by the Government and the rules issued from time to time.
- 10) The authenticity has to be verified of the candidates selected by Gujarat Public Service Commission whether they satisfy the requirements of educational qualification and/or experience, age, citizenship, caste etc. as per the recruitment rules of that post?
- 11) Subject to the rules made and rules issued from time to time.



10) Candidates selected by Gujarat Public Service Commission who satisfy the requirements of educational qualification and/or experience, age, citizenship, caste etc. as per the recruitment rules of the post? Its authenticity has to be verified.

11) For appointing such candidates on temporary basis with immediate effect without medical and police examination as per the provisions of Circular No.: PSC/1068/6554/C dated 12-1-70 of the General Administration Department to the qualified candidates identified for that post. An undertaking shall be obtained from the candidate that if he fails in any way in the medical/police examination, his appointment shall be liable to be canceled with original effect. Such medical and police investigation procedures shall be completed within three months from the order of appointment.

12) After reading and understanding these conditions, the applicant has to give the agreement to the Principal while appearing for the job that the appointment is acceptable and will have to send a copy of the same to this office. (According to the affidavit and checklist)

13) The security and surety bond in the prescribed form set by the government must be given to the Principal by the candidate who gets appointed. (as per affidavit and checklist) and principal has to send a copy to this commissioner's office.

14) If the Ad Hoc Assistant Professor/Contractual Assistant Lecturer in this subject is currently in service and is fully filled, to immediately release the Ad Hoc Junior Lecturer Assistant of this subject and inform this to the office of the action taken by making him present to this Assistant Professor on the vacant post.

15) Candidates getting the appointments should be verified by the Commissioner (U.S.) whether they have the necessary computer skill qualification as per the recruitment rules. And the candidates who get the appointment, in the General Administration Department of the Govt. dated 30/09/2006 published No.: GS/2006/31/Khatap/102005/1519/K and in accordance with the relevant orders, the Principal will collect the certificates of passing the qualifying examination of computer skills and send to the C.H.E.

In addition, whenever it is decided by the Government to pass any qualifying examination, the appointed candidate has to pass within the prescribed time limit decided by the Govt.

16) Two copies have to be sent to the Government on time, (E.R.)/Annual Evaluation Report giving an overview of the performance of these candidates for two years from the date of appointment in the prescribed form.

17) As informed by the Commissionerate, till the information of research proposal in prescribed form and published papers of each year is not provided by you, the candidate's workload will be of 22 hours.

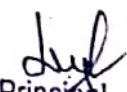
