:: Office Order ::

Based on the reference cited (2), the following Assistant Professors have been selected by the Gujarat Public Service Commission for the position of Assistant Professor in the subject of Sanskrit at Government Arts, Commerce, and Science Colleges under Higher Education in the Gujarat Education Service, Class-2. They have been placed in the pay scale of ₹15,600-39,100-6,000 AGP. The selected candidates are to be appointed on a temporary and provisional basis for a probationary period of two years from the date they assume charge of their position, subject to the conditions outlined in reference (2) and the following conditions, and the conditions outlined in reference (3). The candidates listed below are being appointed on a purely temporary basis at the colleges mentioned against their names.

Conditions:-

- 1. Salary during probation: Under the conditions and provisions of the notification, during this period, the above-mentioned candidates will be entitled to a minimum salary of ₹15,600/and other allowances in the pay scale of Assistant Professor. They will receive this salary until the completion of the probationary period, and no increments will be applicable during this time. Increments will only be granted at the regular rate after they have been appointed to the position of Assistant Professor on a regular basis following the completion of the probationary period.
- 2. Extension of probation: To enhance the efficiency of the probationary Assistant Professors, if they are selected for training or deputed for training, their consent must be obtained, and the probationary period will be extended by the duration of the training. The probationary



period will be extended for the duration of the training after notifying them and obtaining their consent.

- 3. Leave during probation: When orders are issued to terminate the probationary period, the probationary officer will have their probationary period extended by the amount of time they were on leave, in training, or on deputation as per clause (2) during the probationary period. Any leave taken during the probationary period, except for casual leave, will result in the extension of the probationary period by an equivalent duration.
- 4. Transferability and duties: The probationary Assistant Professors must accept any academic or other duties assigned by the government and may be transferred to any location within the state. If their performance during the probationary period is not satisfactory, their probationary service will be terminated upon the completion of the probationary period.
- 5. Subject to court ruling: This appointment is subject to the final decision in the petition LPA No. 471/2018 in SCA No. 2852/2018 pending before the High Court.
- 6. Language examination: The selected candidates must pass the language examination in Hindi or Gujarati, as required by the government, and any other examinations that may be prescribed. If they do not pass the language examination within the prescribed time limit, further increments will be withheld until they pass the examination.
- 7. Seniority: Seniority of candidates who join within the prescribed time will be as per the order given by the Commission.
- 8. Service conditions: Salary, leave, pension, conduct, and other service conditions and disciplinary matters will be governed by the Gujarat Civil Service Rules, Gujarat Civil Service (Conduct) Rules, Gujarat Civil Service (Discipline and Appeal) Rules, and other regulations issued by the government from time to time.
- 9. Verification of qualifications: The principal of the concerned college must verify whether the candidate selected by the Gujarat Public Service Commission meets the educational qualifications and/or experience, age, citizenship, gender, etc., as per the recruitment rules for the respective position.
- 10. Temporary appointment without verification: The candidates must be appointed on a temporary basis without waiting for medical, character, and police verification, based on an agreement obtained from the candidate, as per the circular No. PSC/1068/6554/G dated 12-1-



70 of the General Administration Department. If they fail the medical, character, or police verification, their appointment will be cancelled with retrospective effect. The principal of the appointing college must complete these verifications within three months from the date of the appointment order.

- 11. Confirmation of conditions: The principal of the concerned college must ensure that the above conditions are met and inform this office accordingly. At the time of joining, the candidate must submit an agreement to the principal confirming their acceptance of the appointment under these conditions, and a copy of the agreement must be sent to this office.
- 12. Security bond: The appointed candidate must submit a security and surety bond in the prescribed format to the principal. The principal must send a copy of the bond to this office.
- 13. Passing eligibility examination: Candidates who are required to pass the eligibility examination must do so within the stipulated time frame set by the government. The principal of the concerned college must confirm that this requirement has been fulfilled and report it to this office.
- 14. Annual evaluation report: For a period of two years from the date of appointment, the principal of the concerned college must submit the Annual Confidential Report (E.R.)/Annual Performance Evaluation Report, in the prescribed format set by the circular No. PRO/1086/5068/G.2 dated 08/06/1989 of the S.V.V. department, in duplicate to this office on time.
- 15. Workload until research proposal submission: As per the instructions of this office, until you provide information in the prescribed format about your research proposals and the details of published papers each year, you will be required to work according to the 22-hour workload.
- 16. Reporting to the place of appointment: The appointed candidates must report to the place of appointment within 7 days.
- 17. Passing required examinations: Candidates who are required to pass the eligibility examination must do so within the stipulated time frame set by the government. The principal of the concerned college must confirm that this requirement has been fulfilled and report it to this office.

18. Annual evaluation report submission: For a period of two years from the date of appointment, the principal of the concerned college must submit the Annual Confidential Report (E.R.)/Annual Performance Evaluation Report, in the prescribed format set by the circular No. PRO/1086/5068/G.2 dated 08/06/1989 of the S.V.V. department, in duplicate to this office on time.
