A sanction was given to 907 filled academic temporary posts at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue from 01/03/2020 to 28/02/2021 vide Resolution No. (1). In the current Academic Year 2021-22, the temporary posts 985.5 as per Annexure-A, 62.5 posts vacant for less than a period of 01 year, as per annexure -B, 131.5 posts vacant from 01 to 03 years (posts in abeyance), as per Annexure-C 10.00 posts vacant for over 3 years, thus a total of 1189.5 filled teaching/vacant temporary posts proposal to continue these posts from 01/03/2021 to 28/02/2022 was made by the office of the Commissioner of Higher Education as per Annexure (2), which was under the consideration of the government.

- 4. If there is a need to continue vacant post, proposal for the same should be made 2 months prior to its expiry date with proper documents.
- 5. Post vacant for more than 01 year should be placed in abeyance. And posts vacant for more than 03 years should be cancelled.
- 6. Posts placed in ABEYANCE cannot be filled without prior approval of Finance Department.

Resolution -

A sanction was given to 985.5 filled academic temporary posts out of 1189.5 at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue from 01/03/2021 to 28/02/2022 vide Resolution No. (1). In the current Academic Year 2021-22, the 44.5 posts as per Annexure B posts vacant for less than a period of 01 year, as per Annexure -C 147.5 posts vacant from 01 to 03 years (posts in abeyance), as per Annexure-D 12.00 posts vacant for over 3 years, thus a total of 204 vacant temporary posts.
