Resolution –

A sanction was given to 715.1/2 filled academic temporary posts and 358 vacant posts, thus a total of 1073.1/2 at various Govt. Arts, Commerce, Science, Law and B.Ed. Colleges under Education Department to continue till 28/02/2018 vide Resolution No. (1). In the current Academic Year 2018-19, the 603.1/2 filled posts as per Annexure A, 527 vacant posts as per Annexure -B, thus a total of 1130.1/2 temporary posts. Proposal to continue these posts for a further period from 01/03/2018 to 28/02/2019 was made by the office of the Commissioner of Higher Education as per reference -2 which was under the consideration of the government.

2. After due consideration as per Annexure-A 603.1/2 filled posts and as per Annexure-B 527 vacant posts, thus total 1130.1/2 temporary posts are allowed to continue for a further period from 01/03/2018 to 28/02/2019, subject to the following conditions.

Conditions: -

1. Expenses incurred on these posts are to be made from the provisions of the budget estimate 2018-19.
2. Grant sanctioned by Finance Department must be spent within the prescribed limit.
3. temporary post must be used for the purpose it is sanctioned.
4. If there is a need to continue vacant post, proposal for the same should be made 2 months prior to its expiry date with proper documents.
5. Post vacant for more than 01 year should be placed in abeyance. And posts vacant for more than 03 years should be cancelled.

This resolution is issued as per the sanction accorded by the Finance Adviser (Education) and noting of Principal Secretary on 27.06.2018 in the equal number file.
