As per the letter No; RCT-1013-2354-R-3 dated 06.11.2018 from the Gujarat Public Service Commission, a total of 40 candidates were recommended for direct recruitment to the position of Principal, Class-1, in the Gujarat Education Service, Class-1 (College Branch), under the Commissioner of Higher Education in government colleges. Out of these, the following 36 candidates are appointed on probation for a period of two years in the pay scale of ₹37,400-₹67,000 with a grade pay of ₹10,000/- according to the 6th Pay Commission, at the locations specified in column (5) against their names, effective from the date they assume charge of their respective positions.

Conditions of the Appointment:

This appointment will be subject to the following conditions:

- 1. The merit rank 02 (General Category, Female), 11 (Scheduled Caste), 28 (Socially and Educationally Backward Class, Female), and 34 (Scheduled Caste) recommended by the Gujarat Public Service Commission are appointed to unreserved positions as per the circular No. PVS-1099-MM-13-G.4 dated 29/01/2000 and circular No. PVS-2010-03-900-G.4 dated 23-07-2004 of the S.V.V.
- 2. The candidate must report to the place of their appointment within one month from the date of this order. Failure to do so will result in the cancellation of the appointment.
- 3. During the probation period, the appointee will be entitled to the minimum pay and other allowances applicable to the post of Principal, Class-1 in government colleges. The same pay will continue throughout the probation period, and no increments will be granted during this period. Increments will only be granted after the successful completion of the probation period and upon regular appointment as per government regulations, along with the benefits of pay revision as recommended by the University Grants Commission, if accepted by the state government.
- 4. Any leave taken during the probation period, except casual leave, will extend the probation period by the equivalent duration.
- 5. The appointee must perform any duties assigned by the government and may be transferred to any location within the state.
- 6. If the appointee's service is not satisfactory during the probation period, their service will be terminated without any notice during the probation period. The service during the probation period will be considered purely temporary and provisional.



- 7. If necessary, the probation period may be extended, and separate orders will be issued for the same.
- Upon the satisfactory completion of the probation period, orders for long-term regular appointment will be issued. The candidate will be considered regularly appointed only after such orders are issued.
- 9. The candidate must pass the Hindi or Gujarati language proficiency examination, and any other examinations prescribed by the government. If the candidate does not pass these examinations within the prescribed time limit, further increments will be withheld until the examinations are passed.
- 10. The seniority of the candidates who report for duty within the prescribed time limit will be as per the order given by the Commission.
- 11. The service conditions regarding salary, leave, pension, conduct, and other disciplinary matters will be governed by the Gujarat Civil Service Rules, 2002, Gujarat Civil Service (Conduct) Rules, 1971, and Gujarat Civil Service (Discipline and Appeal) Rules, 1971, and other rules issued by the government from time to time.
- 12. As per the Gujarat Civil Service (Computer Skill Training and Examination) Rules, 2006, the candidate must pass the CCC Plus examination during the probation period. If the candidate fails to pass this examination during the probation period, the probation period may be extended according to the rules, and if the candidate still fails to pass the examination within the extended period, their service will be terminated. Before joining the service, the candidate must provide a written undertaking that they will not claim reappointment in service if their service is terminated for failing to pass the said examination.
- 13. If the candidate wishes to resign after joining the post of Gujarat Education Service, Class-1, they must give notice to the government within the prescribed time limit as per Rule 36 of the Gujarat Civil Service Rules, 2002.
- 14. The candidate must present a written agreement stating that they have read and understood the above conditions and accept the appointment under these terms at the time of joining.
- 15. If it is found that the candidate has deliberately presented incomplete or false information regarding educational qualifications, date of birth, caste, or other details, their service will be terminated at any time without any notice.




- 16. A candidate who has previously served in a government job and is eligible for a reduction in the probation period as per the prevailing government instructions must submit a detailed written application to the appointing competent authority within one month from the date of joining the post.
- 17. At the time of joining as a probationer, the candidate must provide proof to the Education Department, through the Commissioner of Higher Education, that they have been relieved or resigned from their previous government/semi-government job.
- 18. The candidate must take an oath in accordance with the circular No. CDR-1186-UO-2244-G.2 dated 03/12/86 of the General Administration Department at the time of joining. They must submit the oath after taking it.
- 19. The candidate must submit a self-declaration regarding their character history before appointment and undergo a medical examination to obtain a physical fitness certificate from a competent authority within six months after appointment, as per the instructions in the General Administration Department's circular dated 19.09.2016.
- 20. The candidate must submit quarterly reports of their work during the probation period to the Deputy Secretary/Joint Secretary/Additional Secretary in charge of the Education Department through the office of the Commissioner of Higher Education.
- 21. This appointment is subject to the final decision in Special Civil Application No. 20068/2016, Special Civil Application No. 2072/2016, and Special Civil Application No. 15951/2018 pending in the Hon. High Court.
- 22. The candidate must submit an agreement confirming that they have read and understood the above conditions and accept the appointment under these terms at the time of joining.
